DESCRIPTION & USES

Majic Tire Paint is a water-based acrylic designed for application to used and retread tires.

PRODUCTS & SIZES

8-0018 Black. Available in pints.

SURFACE PREPARATION

Surface must be clean, dry and free of oils, grease and loose dust, dirt or other surface contaminants. Stubborn dirt may be removed by scrubbing with a mild detergent solution, rinse with clean water, and allow to dry. Remove grease, oils and wax by wiping surface with Mineral Spirits and allow to dry.

APPLICATION

Shake product thoroughly before use. Majic Black Tire Paint may be applied by brush, cloth or pad. May also be applied, full strength, by low pressure spray. DO NOT THIN. Apply by brush, cloth or pad in thin coats. 2 coats, applied at 1.5 - 2.0 mils each, will yield 1.0 mils of Dry Film Thickness. Do not apply within 4 hours of rainfall. Store this product at temps above 50° F and below 100° F. Do not freeze. For spills, soak up with absorbent material or rags and dispose of in accordance with local, state, and federal regulations.

Method of Application: Brush, roller or spray.

Drying: To touch: 20 minutes. To handle: 1 hour. To recoat: 4 hours. Dry time may be affected by temperature and humidity **Clean Up:** Clean up tools, equipment, and spills with warm, soapy water.
