SURFACE PREPARATION

Make sure surface is clean, dry, and free of dirt.

APPLICATION

Stir thoroughly. Apply with a high-quality brush, roller, paint pad or by spray equipment. Where necessary apply a second coat and allow to dry thoroughly before applying the next coat. Do not apply if surface temperature is below 50° F (10° C) or in direct sunlight.
