SURFACE PREPARATION

New or previously painted surfaces must be free of moisture, dust, dirt, wax, polish and grease. Wash thoroughly and let dry completely. Rust spots on metal must be removed and spot primed. Efflorescence on masony or concrete surfaces must be removed. Wash with a solution mixed with one pound of caustic soda to a gallon water, then rinse thoroughly to remove all traces of caustic and allow to completely dry.

APPLICATION

Stir contents thoroughly until uniform. If using two or more gallons of the same color, mix together and stir paint thoroughly to make sure color is uniform throughout. Apply smoothly and evenly with a good quality nylon brush, short nap roller or pad applicator. Do not paint exterior surfaces when temperatures are below 50° F , in direct sunlight, or if rain is expected within 24 hours. Avoid painting on hot surfaces. CAUTION: Surfaces coated with this product may become slippery when wet. DO NOT THIN.
