# **DESCRIPTION & USES**

A high-quality alkyd resin enamel, containing superior, long lasting rust inhibiting pigments. It applies easily and dries quickly to a long-lasting weatherproof finish. This enamel is a high gloss finish that is non-chalking and fade resistant, providing beauty and protection on most interior and exterior surfaces.

## **SURFACE PREPARATION**

All surfaces, new or previously painted, must be clean, dry and free of oil, dirt, grease, mildew and rust. Rusted metal should be cleaned by wire brushing or sanding. Remove loose and scaling paint by wire brushing, scraping or sanding. Remove oil or grease by cleaning with rags saturated in mineral spirits. Ferrous Metal Prime with either #8-5798 Barricade Red Oxide, or #8-5812 Barricade Gray Primer. For extra protection, spot prime welded joints with the primer, then follow with one full primer coat over the entire surface. Bare Metal: Prime with either #8-5798 Barricade Red Oxide, or #8-5812 Gray Primer. Galvanized Metal: On galvanized metal that is new or non-rusting, thoroughly clean and then prime with either 8-0070 Majic Self-Etching Primer or 8-0009 Majic Universal Acrylic Primer. Previously Painted Surfaces: Painted steel in good condition and non-rusting does require priming. If surface is in poor condition, prepare and prime bare areas as indicated above.

### **APPLICATION**

The surface must be thoroughly dry. Do not paint if surface temperature is below 50°F (10°C), in direct sun light, or on exterior surfaces if rain is expected within 24 hours. Avoid painting on hot surfaces Stir thoroughly until paint is uniform. If using 2 or more containers of the same color, mix together and stir paint thoroughly to ensure color is uniform throughout. To assure penetration into corners and crevices, brush or spray application is preferred. However, application with a short nap roller is satisfactory on large flat surfaces. If brushing, a high-quality nylon or pure bristle brush will give best results. **To thin, use only 8-0750 Majic Non-VOC Reducer.** The addition of one pint of thinner per gallon of Rust Kill Enamel will give the perfect spray consistency without compromising VOC limits.

**Drying:** Normal drying is 6-8 hours to touch and 24 hours to recoat, at 77F (25C) and 50% humidity. Temperature and humidity will affect drying time. **Note:** DO NOT OVER-APPLY. Proper drying and curing time may significantly slowed if applied in excess of 2.6 mils wet, or if recoating too soon.

Clean Up: Mineral spirits immediately after use.
